Minutes of the 1st meeting of the Startup Council held under the Chairmanship of Chief Secretary on 20.02.2017 in the 2nd Floor Conference Hall of Secretariat

Chief Secretary and Chairman of the Startup Council chaired the meeting. Shri Subroto Bagchi, Chairman, OSDA, Shri R. Balakrishnan, IAS, DC-cum-ACS and Shri L.N. Gupta, IAS, Principal Secretary, MSME, Shri T.K. Pandey, Principal Secretary, Finance and other members and officers as per the list in Annexure-I attended and participated at the meeting.

At the outset, the Principal Secretary, MSME updated the the Council members on the progress made so far in terms of release of Operational Guidelines, IED being designated as implementing agency, an Interactive Session of startups with Shri Jay Krishnan, CEO, T-Hub, hiring of BSNL line for Toll Free Startup Helpline, progress of Startup Odisha portal etc. He also apprised the Council about the road map of activities that would be undertaken in the immediate future.

The team from Invest India, an SPV under DIPP Govt. of India, informed the Council that though a total of 295 deals categorized as 'Seed funding' with an investment of 120 million USD took place in the startup space during the year 2016, not a single deal was from Odisha.

Thereafter, the items were discussed agenda-wise, the decisions on which are reflected below :

Agenda 1: Approval of Logo

The Council perused various options and viewed that the logo should be modern and appealing to the startup eco-system. Chairman, OSDA opined that suggestions on logo may be invited through a crowed sourcing competition, where the best 3 entries could be awarded Rs.1.00 lakh, Rs.50,000/- and Rs.25,000/- respectively.

Principal Secretary, MSME stated that Odisha Startup Portal is proposed to be launched on March, 5, 2017. Hence, approval may be accorded for use of one of the logos temporarily. The Council agreed to the logo as given at annexure-III.

Agenda 2 (a): Nomination of Nodal Agencies

The Council went through the list of the institutions proposed as nodal agencies to certify startups. It was opined that the number of nodal agencies could be rationalized and should not be restricted to the government institutions alone. The institutions like Centurion University, which have earned reputation in the area of skill development and NIFT may be included in the list. Principal Secretary, MSME clarified that as per para 7(v) of Odisha Startup Policy, Nodal Agency shall mean reputed Govt. institutions as approved by Startup Council for certifying startups for various categories, which is being proposed for amendment. Once the policy is amended, reputed private institutions could also be nominated as Nodal Agency.

After deliberations, the Council approved the following institutions as nodal agencies for certifying the startups.

(b) Fee Structure of Nodal Agencies

After discussion, the Council approved the fee structure for Nodal agencies on 'per application basis' as follows :

- i. Startup Recognition: One-time fee of INR 1,500 per application.
- Monetary Grant Application: One-time fee of INR 5,000 per application, this shall also include the periodic review as may be applicable.

Agenda 3: Odisha Startup Toll Free Helpline

The Council noted the progress and approved the activation of the helpline with the help of Invest India. The Council also approved the cost of operating the helpline through Invest India at Rs.44,380/- per month for a period of 6 months.

Principal Secretary, MSME informed that the Startup Helpline will be launched soon.

Agenda 3: Odisha Startup Portal

The Council considered the proposal and approved the development of Odisha Startup Portal through NIC at a cost of Rs.15.04 lakh including the cost of post-implementation maintenance for a period of one year. The Council, however, observed that the home page of the portal should be modern and befitting to the startup ecosystem.

Principal Secretary, MSME informed that the portal is likely to be launched on March 5, 2017.

Agenda 5 (a): Incubators

The Council noted the flow chart of Incubator registration and benefits' approval process. The Chairman, OSDA suggested that whereas the present Startup Policy provides for one-time capital grant upto Rs. 1 crore for setting

up of an incubator facility, it should also have a provision for providing matching contribution from Government whenever an incubator is able to raise contribution / grant from an industry/ philanthropic organization/alumni.

After deliberations, the Council resolved to keep a provision in the policy for providing a matching grant upto a maximum of Rs.5 crore on case to case basis, whenever a University recognized under the Central/ State Act is able to raise funding for development of its incubation infrastructure. Such grant from the government shall be used for development of incubation infrastructure including purchase of equipment for the incubation facility. The corresponding amendments may be made in the Odisha Startup Policy and Guidelines accordingly.

(b) The Council agreed to the suggestion that CPSUs/SPSUs may be asked to leverage CSR funds for setting up startup incubators in the state. It accorded in-principle approval to the MSME Department/ IED for approaching the following five CPSUs and SPSU for setting up incubators out of their CSR funds at the institutions indicated below:

The CPSUs/SPSU will be approached for necessary action in this regard.

Agenda 6: Startups

The Council noted the flow chart of startup registration and benefits' approval process. The Council also discussed in detail the incentives allowed to startups under the present Startup Policy. Based on the suggestions emerged during the deliberations, the Council unanimously decided to revise the Monthly Allowance to Startups from Rs.10,000/- to Rs.20,000/- per month and for marketing/publicity assistance from Rs.5 up to Rs.15 lakh, which should also include the cost towards product development. The corresponding amendments may be moved in the Odisha Startup Policy and Guidelines accordingly.

Agenda 7: Startup Odisha Team

The Council considered the agenda and approved creation of two posts in IED along with the compensation as proposed in the agenda for recruitment from the open market through Invest India empanelled vendor. The Council, however, resolved to revise the nomenclature of the post of Startup Director to the Mission Director, Startups and of Startup Manager to Evangelist.

Agenda 8: Ease of Doing Business (EoDB) for Startups

The Council agreed to the recommendation regarding exemption of startups on the lines of SMEs from payment of earnest money and payment of 25% prescribed security deposits while participating in the tenders of Government Departments & Agencies thereunder. Amendment in the MSME Development Policy 2016 may be moved accordingly.

The Council, however, did not agree to the recommendation regarding OSIC acting as Nodal Agency for sourcing of raw material required by the startups. The other points regarding compliance on self-certification etc. were noted by the council.

Agenda 9: MoU with Invest India

The Council considered and approved the proposal of MSME Department for going ahead with signing of an MoU with Invest India, an SPV under DIPP, Government of India for getting support to startup Initiative and MSME sector in Odisha.

Agenda 10: Amendments to Startup Policy, 2016

The Startup India team informed the Council that they have reviewed the Odisha Startup Policy, 2016 vis-à-vis the Startup Policies of DIPP, other States and provisions of Atal Innovation Mission and have suggested certain amendments to the Startup Odisha Policy, 2016, which include elaboration /clarifications in respect of certain existing definitions, addition of new definitions where required, changes in the eligibility criteria of startup for various benefits and certain changes in operating guidelines with a view to simplify. The clause-wise details of the existing provisions and amendments considered and approved by the council are given at annexure-II.

The MSME Department may accordingly move a Cabinet proposal for amendments in the Odisha Startup Policy, 2016 and will effect corresponding changes in the operating guidelines.

Agenda 11: Any other matter with permission of the chair

- (a) The Council resolved to include the Chairman, OSDA and Shri Srikumar Mishra, CEO, Milk Mantra (successful Start up) as permanent member of the Council.
- (b) In order to facilitate mentorship / engagement with the startups and Startup Odisha Initiative, the Council also resolved to organize Startup Meet with successful Odia Startups / Entrepreneurs at least once a year.

The meeting ended with vote of thanks to chair.
