#### Minutes of the 1<sup>st</sup> Task Force Meeting under Odisha Startup Policy held under the Chairmanship of Additional Chief Secretary, MSME on 08.06.2017 at 12.00 Noon in the Conference Hall of MSME Department

Shri L.N. Gupta, IAS, Additional Chief Secretary, MSME Department and Chairman of the Task Force chaired the meeting. Commissioner-cum-Secretary, E&IT & Special Secretary, FD Shri A.K. Meena, IAS and Commissioner-cum-Secretary, SD&TE and CMD, IDCO Shri S.K. Singh, IAS were present. The list of the officers and invitees, who attended and participated in the meeting is given at Annexure-I.

2. At the outset, Additional Chief Secretary, MSME welcomed all the members to the 1st meeting of the Task Force. Thereafter, the agenda-wise discussion took place, decisions on which are indicated below:

### Item – 1 Progress of Implementation of Odisha Startup Policy–2016 (OSP)

CEO, IED briefed the Task Force about the progress of implementation of OSP, 2016 including notification of Startup Council on October 7, 2016; meeting of the 1st Startup Council headed by Chief Secretary on 20.2.2017; Revision in Startup Policy, 2016, Notification of revised Operational Guidelines for the OSP, 2016 on 1.5.2017; launch of toll free helpline by Hon'ble CM and MoU with Invest India on 1st March, 2017; organisation of MSME Trade Fair and Entrepreneurship Week (5-10 March, 2017) with theme on 'Startups'; Interactive sessions with Mr. Jay Krishnan, CEO, T-hub on 17.2.2017 and Mr. Rajan Anandan, MD & VP, Southeast Asia & India, Google on 22<sup>nd</sup> March 2017; Notification of six Nodal Agencies on 24.3.2017; Training programme of the Nodal Agencies on 30.03.2017 & 05.05.2017; launch of Startup Odisha Portal by Hon'ble CM on 1st May, 2017; participation of Team Startup Odisha in TieCON-2017 held at Santa Clara, USA on 5-6th May, 2017; discussion with Prof. Anil Kumar Gupta, Founder of Honey Bee Network and Vice Chairman of the National Innovation Foundation, an exploratory meeting for setting up of Angel Networks held on 3rd June,



2017 etc. The Task Force noted the progress of Startup related activities with satisfaction.

# Item – 2 Startup Applications for recognition of the Startup under Odisha Startup Policy – 2016

CEO, IED informed the Task Force that 61 applications have been received online for recognition as Startup through the Odisha Startup Portal till 2nd May, 2017, the summary tabulated information of which is circulated to all the members for consideration. He added that 46 applications are recommended both by the respective Nodal Agency and the Startup Secretariat at IED, Odisha for recognition. Other 11 applications, though not recommended by the Nodal Agencies, have been examined at the Startup Secretariat and are recommended to the Task Force for recognition. The remaining 4 applications are not recommended. After the detailed deliberations, the Task Force decided as follows:

#### Item – 3 Incubator Applications

CEO, IED informed that they have received total 3 applications for recognition as Incubator through the Startup Odisha Portal till 31st May, 2017. These are from Asian School of Business Management, KIIT TBI and Foundation for Technology and Business Incubation, NIT, Rourkela. He added that they have recommended KIIT TBI and Foundation for Technology and Business Incubation, NIT, Rourkela for recognition as Incubator.

After deliberations, the Task Force agreed to the recommendation of Startup Secretariat and accorded approval to the applications of KIIT TBI and Foundation for Technology and Business Incubation, NIT, Rourkela for recognition as Incubator under the OSP, 2017.

# Item - 5 Delegation of power to the CEO, IED and Startup Secretariat for recognition of Startups

After deliberations, the following was decided:

3.	Applications in which both the nodal agency and the Startup Secretariat headed by CEO, IED are not able to arrive at unanimous decision	May be referred to the Task Force for consideration.	



However, the information regarding number of startups approved for recognition and the number of applications rejected may be informed by the Startup Secretariat to the Task Force in its next meeting.

#### Item − 6 Any other matter

- (i) Draft advertisement for recruitment of one Mission Director and one Evangelist was placed before the Task Force, which was gone through. It was decided unanimously that the task of recruitment may be assigned to the headhunting agency of Invest India, as already decided in the Startup Council meeting held on 20.2.2017.
- (ii) Detailed programme for the Innovation Festival proposed during August leading to Startup Conclave in October, 2017 may be firmed up and placed before the Startup Council for consideration.
