# Minutes of the 17<sup>th</sup>meeting of the Task Force under Odisha Startup Policy held on 03.11.2020 at 11.00AM.

The 17<sup>th</sup> meeting of the Task Force, constituted under Odisha Startup Policy-2016, was held on 03<sup>rd</sup> November 2020 virtually under the Chairmanship of Principal Secretary, MSME. The list of members, who were present and participated in the meeting, is given at the Annexure.

The following are the decisions taken agenda-wise:

### 1. Confirmation of minutes of the 16<sup>th</sup> Task Force Meeting

The minutes of the 16<sup>th</sup>meeting of the Task Force held on 27<sup>th</sup> August 2020in the Conference hall of MSME Department, Odisha under the Chairmanship of Shri Satyabrata Sahu, IAS, Principal Secretary, MSME were circulated to all members. There being no comments, the Task Force confirmed minutes.

# 2. To consider a note on the action taken on the Minutes of the 16<sup>th</sup> Task Force meeting held on 27<sup>th</sup> August 2020, in the Conference Hall of MSME Department, Odisha.

Evangelist, Startup Odisha informed the Task Force of the actions taken on the minutes of the Task Force held on 27th August 2020

### 3. Startup Recognition

Evangelist, Startup Odisha informed the Task Force that 90 new Startups have been given recognition after the  $16^{th}$  Task Force, thus taking the total number of the recognised Startups to 774 under the Startup Odisha Initiative. The Task Force took note of the progress made.

#### 4. Financial Assistance to Startups

- Evangelist, Startup Odisha informed that out of 30 recommended applications for Monthly allowance received from Nodal agencies, 19 have been recommended by the Startup Secretariat, out of 10 recommended applications for Product Development and marketing assistance received from Nodal Agencies, 06 applications have been recommended by the Startup Secretariat and out of 01 recommended applications for Need Based assistance received from Nodal Agencies, 01 have been recommended by the Startup secretariat.
- He added that, the Sub-committee of the Task Force, held its meeting on 23<sup>rd</sup> & 30<sup>th</sup>October 2020 under the Chairmanship of Director Industries for further examination of the above-mentioned applications for financial assistance as recommended by the Startup Secretariat with presentations from the Startups. The Sub-committee after verifying their eligibility and basis on detailed presentations have recommended 14 applications for Monthly allowance, 5 for Product Development & Marketing Assistance and 1 application for Need Based Assistance.

• He presented the recommendations of the Sub-committee before the Task Force. The Task Force considered the recommendation of the Sub-committee and after detailed deliberations, unanimously took the following decisions applicant wise:
