Minutes of the 10th meeting of the Task Force constituted under Odisha Startup Policy-2016 held on 10th October, 2018 in the conference hall of MSME Department, Odisha Secretariat

The 10th meeting of the Task Force, constituted under Odisha Startup Policy-2016, was held on 10th October 2018 in the conference hall of MSME Department, Odisha under the Chairmanship of Shri L.N. Gupta, IAS, Additional Chief Secretary, MSME. The list of the members, nodal officers and invitees, who were present and participated in the meeting, is given at the Annexure.

The following are the decisions taken agenda-wise:

Item 1. Confirmation of Minutes of 9th Task Force Meeting

The minutes of the 9th meeting of the Task Force held on 9th August 2018 were circulated to all members vide MSME letter no. 5224/MSME, dated 10.08.2018. There being no comments, the Task Force confirmed the minutes.

Item 2. To consider a note on the action taken on the Minutes of the 9th Task Force meeting held on 09.08.2018, in the Conference hall of MSME Department, Odisha.

CEO, IED informed the Task Force of the actions taken on the minutes of the Task Force meeting held on 09.08.2018.

The Task Force suggested that a progress report of the Startups, who have received their complete grant, be prepared and presented during the next Task Force meeting.

Item 3. Startup Recognition

CEO, IED informed the Task Force that 36 new Startups have been given recognition after the 9th Task Force, thus taking the total number of the recognised Startups to 302 under the Startup Odisha Initiative.

Item 4. Financial Assistance to the Startups

- CEO, IED informed that out of 10 applications for Monthly Allowance recommended by Nodal Agencies, 8 were recommended by the Startup Secretariat. Similarly, out of 3 recommended applications for Product Development and Marketing Assistance received from Nodal Agencies, 3 were recommended by the Startup Secretariat. Out of 2 recommended applications for Need Based Assistance received from Nodal Agencies, 2 were recommended by the Startup Secretariat.
- CEO, IED informed that the Sub-committee of the Task Force, held its meeting on 04.10.2018 to further examine the above-mentioned applications for financial assistance as recommended by the Startup Secretariat with presentations from the Startups. He presented the recommendations of the Sub-committee meeting before the Task Force as placed at Annexure-1.
- The Task Force considered the recommendations of the Sub-committee and after the detailed deliberations, unanimously took the following decisions applicant wise:


