**NOTIFICATION**

**No.-S&I(IED)-09/2018 1696 /MSME, dated 13-03-2018**

Pursuant to provision contained in para 10.2.1 of Startup Odisha Policy-2016, Government has been pleased to decide the following:

- i. 20% of the total procurement by State Departments/ State PSUs shall be mandatory from Micro & Small Enterprises or Startups of the State.
- ii. There would not be any minimum turnover requirement for Micro, Small Enterprises and Startups in participating in public procurement process.
- iii. All State Government Departments and Agencies will additionally relax condition of prior experience with respect to Startups in all public procurements subject to meeting of quality and technical specifications.




