Also Bidders have to submit the undertaking at the time of event.

4. If only one bidder qualifies in the final evaluation, then empanelment will be done on the basis of General Financial Rule of Department of Finance, Govt of Odisha.

5. All bidders are required to submit the non-refundable processing fee as per the terms of RFP. Relaxation for the processing fee will not be considered at all.
